Using herbal ingredients, Dr. Mercola's Herbal Repellent Collar for Small Dogs and Puppies repels and controls fleas and ticks, reducing the number of bites.

CAUTIONS: KEEP OUT OF REACH OF CHILDREN. *For external use only.* Avoid contact with skin, eyes and clothing. If product gets onto skin, wash with plenty of water and mild soap. If product gets into an eye, hold eye open and gently flush with water for 15 minutes.

KEEP OUT OF REACH OF PETS. *For external use only.* Avoid contact with eyes, nose, and mouth. Sensitivities can occur after using any flea or tick prevention program. If your pet shows sign of irritation, rinse them thoroughly, bathe your pet with mild soap and rinse again. If signs continue, consult a veterinarian immediately.

Not for use on puppies under 4 months of age. Do not use this collar to fasten or restrain your pet. Not for aquatic use.

STORAGE AND DISPOSAL: Store in a cool, dry place out of direct sunlight. After use, dispose of the collar and packaging according to your local waste regulations.

DIRECTIONS FOR USE: To be used on Small Dogs and Puppies (4 months and older) with a maximum neck circumference of 21 inches. Remove the herbal collar from the bag and fasten it around your pet's neck. A correct fitting will enable two of your fingers to be comfortably inserted between the collar and their neck. **LOOSEN THE COLLAR AS YOUR DOG GROWS BIGGER.** Cut off and dispose of any excess length of the collar which goes beyond the buckle. Wash hands with soap and warm water immediately after fitting.

Dr. Mercola's Herbal Repellent Collar is waterproof and does not need to be removed until it's time to replace the collar.

For continuous protection, replace collar every 3-4 months and use simultaneously with Dr. Mercola's Topical Herbal Repellent for Dogs (4 months and older).
